IRS has been directed to pay out refunds electronically as soon as deemed feasible. We believe there will be a 12 – 24 month phase in period before Executive Order 14247, Modernizing Payments to and from America's Banking Account is mandated. The same is the case for payments to IRS, they are also directed to receive payments electronically as soon as it is feasible. This includes any amount due upon filing and estimated payments. We can set those to pay electronically when we file, OR you can set up an account with IRS and Illinois to initiate payments there.
